I. Establishment of Land Ports Authority of India

India's land border of 15,106.7 kilometres with our neighbours Bangladesh, Bhutan, China, Nepal, Myanmar, and Pakistan intersect various traditional and new routes connecting people on both sides. Some of these routes were in use prior to formalisation of land borders between these countries for connecting people and trade. Therefore development of Land Ports at these routes has been a priority for Government of India.

Government of India through Ministry of Home Affairs established Land Ports Authority of India (LPAI) as a statutory body under the Land Ports Authority of India Act, 2010. LPAI is mandated under LPAI Act to develop, sanitize, operate and manage the state-of-the art-facilities (Land Ports) for cross-border movement of passengers and goods at designated points along the international borders of India. The first Land Port, at Attari, Punjab, was developed and operationalized in 2012 by LPAI on a traditional trade route between India and Pakistan.

Land Ports provide enabling infrastructure to bring all stakeholders under one roof, including but not limited to, Customs, Immigration, Border Guarding Forces (BGFs), Plant and Animal Quarantine, Land Port Health Units (LPHU) and Food Safety and Standards Authority of India (FSSAI).

LPAI has completed eleven glorious years of service to the nation in March 2023 and has developed and operationalized nine Land Ports during the period. These Land Ports have been operationalized along land borders with Pakistan, Nepal, Bangladesh and Myanmar. LPAI intends to operationalize three more Land Ports at Rupaidiha, Dawki and Sabroom in the next financial year.

III. Strengthening human resources

- 1. LPAI filled 11 vacant posts in cadre of secretary, managers, assistant engineer (civil), assistants and stenographer.
- 2. LPAI received large number of applications from students with diverse educational background for the summer internship programme for FY 2022-23. The selected students undertook studies covering areas such as sustainable land port, digital transformation and automation, leveraging smart technologies and strategies for optimizing supply chain management of hazardous materials among others.
- 3. Regular training and development programmes were organized by LPAI to enhance the capacity and efficiency of our employees. Trainings were also organised in collaboration with prestigious organizations like FSSI, FIEO and CVC.

IV. Advancing gender mainstreaming at India's Land Ports

The National Trade Facilitation Action Plan 2020-23 focuses on promotion of "Gender inclusiveness in trade". LPAI recognizes the importance of robust research in advancing gender mainstreaming initiatives and LPAI is actively supporting research studies in this area. These studies are providing valuable data and insights for targeted interventions and policies for driving meaningful progress in mainstreaming gender at India's land ports.

V. Publications related to Land Ports

LPAI is committed to enhance the experience of users of its facilities. LPAI continuously tracks operational parameters of its Land Ports and publishes magazines and newsletters covering operational statistics on a regular basis. During FY-2022-23 LPAI published following reports/magazines:

- (i) LPAI's bi-annual magazine "Land Ports: Gateway to India"
- (ii) LPAI's newsletter "Connect"
- (iii) Social Cost-Benefit Analysis of ICPs in India

VI. "Azadi Ka Amrit Mahotsav" at Land Ports

"Azadi ka Amrit Mahotsav" was celebrated at LPAI Head quarter and at all the operational land ports. As part of celebration of "Azadi ka Amrit Mahotsav" various events were organized at land ports such as welfare activities for employees, stakeholders and locals, social activities, and honouring freedom fighters/soldiers among others.

Some of the key events organised at Land Ports were as follows

- 1. Competition for local artisan at Sutarkandi land port
- 2. Health camps were organized at Land Ports (Petrapole, Jogbani, Sutarkandi, DBN, Raxaul) for the benefit staff and stakeholders.
- 3. Blood donation camp at Land Ports.
- 4. Painting and colouring activities for local students and painters.
- 5. Friendly volleyball matches for staff and stakeholders at Srimantapur land port.
- 6. Various cultural program for staff and stakeholders at land Ports.





I. Summary of annual financial results for FY 2022-23

(i) Grant-in-Aid

In Financial Year 2022-23, the opening balance of Grant-in-Aid (Capital) was Rs. 7.00 lakh. LPAI received total Grant-in-Aid of Rs. 360. 25 crores from Ministry of Home Affairs for FY 2022-23. The Grant-in-Aid received under head of Capital, General and Salary was Rs. 325.00 crore, Rs. 27.00 crore and Rs. 8.25 crore respectively.

The total utilization of grant in FY 2022-23 was Rs. 371. 2 crores. The utilization against respective heads of Capital, General and Salary was Rs. 323,46 crores, Rs.39.55 crore and Rs.8.51 crore. Thus, leaving an unspent balance of Grant amounting to Rs. 1.80 crore as on 31.03.2022 was auto surrendered on 31.03.2023. The additional expenditure of Rs. 13 Cr was done by internal receipts.

ii) Income tax exemption

LPAI is exempted from TDS under Income Tax 03-clause (i), of first provision to clause (23C) of section 10 (for application covered under sub clause (iv) of Clause (23C) of section 10 with validity up to FY 2026-27.

(iii) Income tax refund

During the FY 2022-23 Income Tax Return of LPAI for the FY 2020-21 and 2021-22 process has been completed and the refund amounting to Rs.58.82 lakh of the FY 2021-22 has also received from the Income Tax Department.

(iv) Treasury Single Account System (PFMS)

As per the direction of Ministry of Finance, Government of India Treasury Single Account (TSA) system was implemented in LPAI with effect from 01.04.2021

(v) Fixed assets:

LPAI possess fixed asset worth Rs. 1,733.23 Cr. These fixed assets are inclusive of land under passion of LPAI, buildings Construction work in progress and other fixed assets as below.

As per Rule-230(8) of General Financial Rule-2017 the interest earned during the FY 2022-23 on Grant in Aid amounting to Rs.8.41 crore is shown in the accounts is payable to consolidated fund of India, (PAO, Secretariat, MHA) and paid.

II. Initiatives for efficiency improvement and revenue enhancement

- 1. National Time Release Study (NTRS), 2022 covering 15 key ports was published by CBIC. The salient outcome with respect to land ports were as follows
 - a) Report covered two crucial land ports Raxaul and Petrapole.
 - b) The import release time at these ports was 17 hours against NTFAP benchmark of 24 hours and
 - c) Average export release time was 22 hours, which is substantial reduction of 80% in comparison to previous year.

The chart below provides comparison of the export clearance time with previous year and other mode of exports.




Figure 2: Comparative Export time release data in hours



- 2. Revised tariff for parking, weighment, and storage was notified on 16th Aug. 2022 at Jogbani land port.
- 3. Additional weighbridge operationalized to facilitate import cargo on 31st Dec. 2022 at Jogbani land port.
- 4. Diversion of bulk cargo, such as coal, via Raxaul land port was notified by customs for cargo originating from Raxaul rail yard and bound for Nepal.
- 5. Meeting of BREIF members on the study of "Co-ordination and Border management at Land Ports in BBIN countries" was held at Jogbani land port on 24th Aug. 2022.
- 6. Solar power plant of capacity 1300 Kw was commissioned at Attari land port and has resulted in approx. 50% reduction in electricity cost.
- 7. LPAI has developed and operationalized secure parking space on a nominal charge at Dera Baba Nanak land port.
- 8. Suvidha portal was rolled out at Petrapole land port on 29th July 2022 in coordination with IT Department, Govt. of West Bengal resulting in significant reduction in clearance of export vehicles.
- 9. LPAI has operationalized a Fire Personnel Training Centre on 19th Sept 2022, at Jogbani land port, to enhance fire safety and preparedness and established fire stations at various land ports.
- 10. A Help Desk has been operationalized, at Agartala land port, for facilitation of passengers.
- 11. The 3rd Meeting of the Coordination Committee convened on 2nd September 2022 under the guidance of Secretary (BM) MHA, with the primary objective of optimizing processes for the efficient management of goods and people traversing our land borders.
- 12. Land Ports Authority of India is aligned with PMs digital India initiative in conformity to this LPAI has enabled option for Unified Payments Interface on LPAI official website (https//: www.lpai.gov.in).
- 13. Diversion of traffic of LCS Raxaul to ICP Raxaul has started since January 2023, and all the trade activities are taking place via Raxaul Land Port.

III. Operational performance and progress of sanctioned projects

a. Trade and Revenue:

Trade worth Rs. 76,320 Crores was facilitated through Land Ports during the Financial Year 2022-23. LPAI earned revenue of Rs. 30.03 Cr. from the services provided at land ports. The details of trade and revenue are provided in table below

In addition to the above, establishment of Land Port at Sabroom, Tripura is a standalone project approved in October 2020. About 62% of construction work is completed and LPAI will commission it in the FY 2023-24.

IV. New projects and expansion schemes

- 1. LPAI has received "In-principle" approval for upgradation of 25 Land Customs Stations to Land Ports. The detailed project-cum-feasibility report for these Land Customs Stations is under preparation.
- 2. Assessment of the viability for the establishment of commercial advertising initiatives, petroleum dispensing infrastructure, food and beverage services, and medical tourism facilitation centres is proposed at Land Ports.






Figure 4: Revenue via Land Ports during last 2 financial years





Figure 5: Details of Revenue receipt

III. Annual Plan of Financial Year 2023-24

LPAI is in the process of operationalizing three new land ports at Dawki, Sabroom (both located along the Indo-Bangladesh border), and Rupaidiha (situated along the Indo-Nepal border). In addition, following are few of the planned activities of respective departments

- 1. The land acquisition for the development of Bhittamore land port is to be completed.
- 2. Construction of second cargo gate at the Petrapole land port is to be completed.
- 3. The development project at Rupaidiha along the Indo-Nepal Border is to be completed.
- 4. Development of Sabroom land port to be completed in FY 23-24.
- 5. Ongoing development works are focused on the establishment of Land Ports at Sunauli and augmentation of Sutarkandi land port.
- 6. The construction of Passenger Terminal Building at ICP Petrapole is to be completed.
- 7. Accommodation facilities for Border Guarding forces are being developed at strategic locations, including Raxaul, Agartala, Moreh, Dawki, and Petrapole.
- 8. Development of Land Port Management System (LPMS) to be initiated and developer to be selected in FY 23-24.
- 9. Renovation of cold storage facilities at Attari and Petrapole land ports to be completed to ensure ideal conditions for the storage of perishable goods.

SIGNIFICANT ACCOUNTING POLICIES :

1. ACCOUNTING CONVENTION

Basis of preparation of Financial Statements: The financial statements have been prepared under historical cost convention in accordance with generally accepted accounting principles. The Authority adopts accrual system of accounting unless otherwise stated. Revenue from ICPs, Rent and interest from Saving Bank Accounts and expenses such as salary, electricity, telephone, professional services and other misc. expenses are calculated on accrual basis.

The form of accounts has been prepared in the format prescribed under Section-13 of Chapter-IV and Section-14 of Chapter-V of the LPAI Act, 2010, which is in conformity with the format prescribed by Govt. of India vide its communication bearing no. F-4-21/2002-45 dated Feb 25, 2003.

2. FIXED ASSETS

- Fixed Assets are stated at cost of acquisition inclusive of inward freight, duties and taxes and incidental and direct expenses related to acquisition. In respect of projects involving construction, related pre-operational expenses/income (including interest on loans/deposits for specified project prior to its completion) form part of the value of the assets capitalized. Assets have been capitalized as per details furnished by RITES, IRCON, shapoorji, MANIDCO and others PMC on the basis of running bills of the Contractor subject to adjustment at the time for settlement of final bill of each ICP.
- Fixed Assets received by way of non-monetary grants (others than towards the corpus funds) are capitalized at values stated by corresponding credit to Capital Reserve.
- Value of assets adjusted, wherever necessary, under the head addition/deletion during the year.

3. DEPRECIATION

- Depreciation is provided on Written Down Values as per rates specified in the Income Tax Act, 1961 which is amortized over the residual life of the respective assets.
- In respect of additions to/deductions from fixed assets during the year, depreciation is considered on Written Down Values.

4. GOVERNMENT GRANTS/ SUBSIDIES

- Grants-in-Aid: The Grant in aid received from Ministry of Home Affairs, Government of India for the year considered on accrual basis and provision has been made based on Grants sanctioned during the year.
- Capital Grants : Government Grants of the nature of contribution towards capital cost of setting up projects are treated as Capital Reserve. Capital Grants received and interest accrued on it shown as Capital Reserve in Schedule 2 of the Balance Sheet.
- As per Rule-230(8) of General Financial Rule-2017 the interest earning on Grant in Aid amounting to Rs.8.41 crore is shown in the accounts as payable to consolidated fund of India, (PAO, Secretariat, MHA).
- Government Grants/ subsidy are accounted on realization basis.

5. LEASE

Lease rentals are expensed with reference to lease terms.

6 Taxation
